 - 1. **FYI: CASP Review:** On June 28, 2013, the Los Angeles City Council adopted Ordinance No. 182,617 which established the Cornfield - Arroyo Seco Specific Plan (“CASP”)...The Plan includes multiple Affordable Housing Strategies, one of which is Strategy B. Strategy B is limited by a footnote to expire after a five year period from the date of Plan Adoption. As such, five years after plan adoption, the market value square footage is reduced by half unless the City Council legislatively acts to remove this time limit. Under direction of City Council Motion (Cedillo; CF 13-0078-S1), Cornfield – Arroyo Seco Specific Plan: Extension of Affordable Housing Bonus Option, the amendment proposes to remove the Bonus Square Footage Table Footnote, eliminating the five year time limit, and allowing the original Affordable Housing Strategy B incentives to continue.

The Friends of Cypress Park request a letter of support from the GCPNC for establishing an annual parade to begin in 2020. (see attached draft)
- B. **Discussion and Possible Action: Monthly Saturday Pop-Up Cleanups**
Planning Committee requests board approval to hold pop-up cleanups on Feb 16, March 16, April 13, May 18, June 15. Meeting location: Library 10AM. Location of each cleanup TBD as needed. **(No additional funding request; \$729.57 still remains** from original request for \$1000 from Outreach for clean-ups. This item is required to get the events approved by the city clerk’s office.
- C. **Discussion and Possible Action: Beautification & Street Cleaning project tools**
Gas Blower - \$350 with warranty; \$250 safety vests – Total Request: \$600 from Outreach. Current Outreach Available: \$4225
- D. **Discussion and Possible Action: Facebook Boosts & Elections**
\$200 a month for 3 months. \$600 total from Elections Budget. Current Election Budget Available: \$2,000.
- E. **Discussion and Possible Action: Cypress Park Music Festival**
March 31 @ Rio de Los Angeles State Park. Amount Requested: up to \$3500 (insurance, stage rental, portable bathrooms, water & snacks, outreach and advertising) from Outreach budget. Current Outreach Available \$4225.

9. Neighborhood Purpose Grants - Action Items (30 minutes)

A Neighborhood Purpose Grant is applied for by a 501 (c) 3 Non-profit organization or an LAUSD public school to request a grant from the Neighborhood Council that will benefit the community or serve a public purpose. Our board will hear presentations from the organization listed below. We have **budgeted \$4600** to distribute in Neighborhood Purpose Grants at this meeting but may decide

to roll that budget into a future month. The board may ask questions of each organization. After all presentations, the public will have an opportunity to comment on their funding priorities.

Note from Treasurer: The additional \$600 this month was voted on in the December meeting with the intention to find a non-profit to help support the work of the Good Samaritan Group at Divine Savior in feeding the homeless – a service the board can no longer fund directly. The non-profit who had volunteered to serve in this faculty has not yet received their tax status, so are delaying their request to our April meeting.

A. Lummis Day Festival - \$1000 to support the annual Lummis Day Festival. Free event that includes music, art, and other activities for families. (held over from October meeting). **Total Amount Requested of GCPNC: \$1000**

B. El Rio de Los Angeles Veterans Collaborative

The mission of the "El Rio de Los Angeles Veterans Collaborative" is build a Veterans Memorial" to memorialize the service and sacrifices of Veterans of the United States of America, past and present at the Rio de Los Angeles Veterans Site, located at 1900 N. San Fernando Rd., Los Angeles, CA 90065. To pay for the installation of a flag pole (by approved City vendor) also purchase flags, lighting, and military logs emblems. The local State Ranger will include the veterans monument to their schools tours. **Total Requested of GCPNC: \$3,000**

C. C.A.S America Veterans Foundation

CAS American Veteran Foundation is seeking to train and provide job placement for US Veterans and their families, as well as our Youther (18 to 24 years old). Both category of training are part of a high unemployment rate in the US. The training is BSIS CA certified. Physical security is the 2nd growing industry in the US> It is one day training with an immediate background check, along with online application submission. The state approves guard card applications withing one week, up to six weeks. Individuals are able to become gainfully employed fast; provided no past criminal history... We want to train 25 individuals which will cost exactly \$5000. **Total Amount Requested of GCPNC: \$5000**

D. Avenue 50 Studio

We want to create a Los Angeles masterpiece of a community beautification project in the form of a mural/outdoor museum at the border of Cypress Park, Lincoln Heights, and Highland Park....We are intending to draw focus to the natural beauty of our neighborhood specifically to the view of flat top itself. **Total Amount Requested of GCPNC \$1000**

E. Instituto De Educacion Popular del Sur de California (IDEPSC)

The Cypress Park Community Job Center hosts community cleanups, some in partnership with the neighborhood council. We've used the previous pressure-washing purchased with the neighborhood grant from last year (again, thank you somuch!), as well as several gardening and clean-up tools. But the electric pressure-washer requires many extension cables and limits the accessibility of the machine, as does the lower PSI. We would better serve the community if we had at our disposal better cleaning equipment (see attached list). **Total Requested from GCPNC: \$848.41**

F. SELAH

SELAH hosts homeless outreach trainings and outreach events to help build relationships with local neighbors experiencing homelessness and connect them with services. The organization is hosting a hygiene kit drive to gather supplies for outreach events. **Total Requested from GCPNC: \$300**
