Violations: storage of abandoned vehicles

Unapproved occupancy or use of the building as automotive repair shop

The remodel of the 2 story structure was constructed without the required permits and approvals

Vision Zero Updates on CD1 on the inclusion of Cypress Park on Vision Zero planning: Figueroa Corridor – Cypress Park has TWO High Injury Network sections according to DOT: Figueroa to San Fernando along West Ave 26 and Figueroa from Ave 26 to Ave 37. From Elsy Hernandez: "we are going to have people leading in the vision zero project come out and explain exactly what it is and what it's going to do for our community, if there are any particular questions let me know our office can facilitate the info."
