

- 25 people win out of 300-400 enter, Lance won
- Some live entertainment at location, small local groups, unsigned, fundraisers
- **Lance:** owned permanent records, since 2006 – LA 2011, been in NELA since 2011, eagle rock to highland park 2014, operated 3 locations, purchased Café NELA from Dave – record store, live music, bar
- Expanding record store easing into more bar/nightlife in the evening; won liqueur license lottery; just beer no wine currently
- **Bryan: What will be different about your bar?**
  - Lance: Vibe is different from neighborhood watering hole, music-oriented; respectful of records; people want to do something other than drink: show/records; offers something beyond a random bar
  - No net increase of license – change of type
- **Anthea:** What is the status of the club down the street? Outdoor space?
  - Don't know
  - Outdoor space: previously mess of furniture, paved over dirt, put up a privacy fence between property and parking lot, tables and chairs
- **Ash: how does this help local businesses?**
  - Lance: No kitchen so we encourage people going next door /La Victoria – stoked on being busier because of us  
More than just a bar, a record store/performance space  
Youth emerging stronger, Australia fire benefits
- **Oscar: Ongoing culturally appropriate programming, working in the community, community pricing; how do you bring the community in as well?**
  - Lance: Interested in serving the community; important to be respectful and work with the existing businesses to bring each other up; People were asking about food trucks – run it by Blanca next door first; space is small so we can't have the Rolling Stones but it is good for small local groups; hyper-local underground
- **Rory: Parking?**
- Lance: Unmetered / not been an issue, capacity is only 98 for the space so it's never going to get out of control, 6 years Café Nela Ash motion: Recommend to board that we support because of neighborly vibe

  - 3 parcels, zone allows restaurants by right
  - 3 buildings – 7 separate store front, 2 existing business, Tierra Caliente and a liquor store,
  - Change use of 2 vacant spaces to turn into restaurant that serve alcohol
  - Tierra Caliente: 900 sq ft – try to help keep them there and do a lot of the TI and Jesse wants to sell beer and wine, people want a beer with a burrito or taco – extended lease and helping to clean up their space; build out kitchen and bathroom and give them space to the back
  - 1209 biggest portion 1000sqft, 40 int, 20 ext
- **Anthea: Who is dream tenant?**
  - **Vartan:** A market that offers fresh produce and meat and prepared food to sit and eat – talking to a couple of operators / plans pushed back – using time to refine plan
  - 1215 Cypress – 20 seats
  - Adding smaller restaurants to the building
  - King Taco – only other restaurant
  - Small, neighborhood contributing
- **Chris: Alcohol – 1217 beer and wine, 1215 beer and wine, 1209 full alcohol, release from hours: 7 – midnight, 9-1:30 F/Saturday**
  - **Commercial corner restrictions – open until 11pm**
  - **Oscar: who could be potential operators? Meat/Produce**

**business there before – first right to return? Locally based businesses about using the space / just recovery framework for who has access to these opportunities – are there opportunities for the leases to come from a priority for business that are owned by people of color? Or first right of return?**

- Vartan: Want to encourage people in the neighborhood; example: related to project, someone who reached out – mid 20s guy reached out, local grew up here, barber – wants a space in Cypress Park
- Looking for young energy from the neighborhood or surround
- Structuring leases- TI \$ going into renovation so they don't have a huge upfront expense
- Things are weird but there's a lot of talent out there
- **Anthea: China Lola? Pop-up SE Asian influence in front of footsy / taqueros – what's the plan to bring them in / help that happen?**
  - Vartan: Because of covid things are going to get delayed – 3-6 months is now 9-16 months. We don't want it to be empty in the meantime, make a test kitchen, temporary
  - Maybe there's a way to activate on the sidewalk
  - Get creative
- **Ash: concern over back patio and noise for neighbors**
  - Buffer and sound buffer to deal with the back courtyard
  - Designed the back space not to disrupt people in the house
  - People in houses are excited that they'd be next door
- **Oscar: include in the leases prioritizing local**
- **Anthea: it will work to your advantage to work locally over the next few years**
- **Oscar: how long will you be here?**
  - Vartan: my entire life revolves in 1 mile radius, interactive installations for bands in warehouse, starting to purchase properties like this in Glassell and Cypress, intend to hold properties
- **Ash: parking? Impact of neighbors**
  - Other parking to lease space
  - Ride Share drop-off

Oscar motions: The committee recommends the board support these CUB applications with the understanding that the building owner will work to include businesses that are local and prioritize local hiring

while supporting leases that are favorable to keep local businesses.

- Clint Birdsong comment: support, some of the businesses that were there – have you talked to those former tenants / cool for there to be some thoughts about parking – coffee shop across the street, valet stand to drop off cars – give people an option to return
- Vartan – when some tenants left – the meat market we helped find a new space, no plans to leave their new space, one of the other guys who is running a family store sets up a table
- Vote: Ash – yes, bryan – yes, Oscar yes, Rory yes – Anthea yes

- On June 11th, City Planning will take the Restaurant Beverage Program's (RBP) revised draft ordinance to the City Planning Commission. The proposed ordinance would shorten the processing time and lower the cost of obtaining a Conditional Use Permit to serve alcoholic beverages for certain sit-down restaurants.
- Discuss and consider proposing a CIS for the Governing Board for June 9 meeting.
- Anca – owner of Lemon Poppy speaks/explains:
  - An alcohol license is really profitable, you can double your average check
  - People don't need to be hungry to order alcohol
  - Requires less people to serve the alcohol
  - 7 people to make 2K dollars, 2 people and a couple of hours for a bar to make that money
  - Lemon Poppy – current cost of beer/wine license - \$30,000, of that \$15,000 is LA city fees; \$9000 filing fee, other \$15000 goes to the expediter, fees are flat, it doesn't matter where you are; this would cut out a lot of months and money
  - Lottery – saves you in state fees, this is just city elements
  - So only licenses go to those with investors or deep pockets
  - Especially for restaurants / community like ours
  - Looking at the bank building on Ave 33/Eagle Rock – has been under construction - \$500K and wait 2 years to have a fully licensed/permited restaurant to start – the space went to
  - Weights the favor to big restaurants / groups – year to take community comments, small community restaurant can wait that amount of time
  - In neighborhoods like ours – during the day we lose customer base, busier on weekends, mimosas on the weekend
  - Existing business could flourish even more; not about alcohol license so much as supporting existing community businesses, people expect to be able to have beer or wine, bathrooms that fit the requirements, structurally you have to have 2 bathrooms,

We support pre-existing businesses; priority to smaller restaurants; progressive fee schedule; no cost to community restaurants; strongly
