The conversation centers on how late into the year the shelters are open and if they are tied to cold weather, but there is no more cold weather forecast, will an extension actually allow more beds. Romana points out that there are no beds in NELA. Clint suggests the addition of language requesting beds available near the Cypress Park neighborhood and Romana suggests language to tie the winter shelter program to the summer cooling centers program to make more beds available year-round.

Teresa arrives at 7:15pm and is brought up to speed on the item.

Board motions to approve a FOR action in support of the motion with the additional notes that the GCPNC requests that beds be made available to people near the Cypress Park neighborhood and that the city consider combining the winter shelter programs with the summer cooling program with the aim of offering a year-round program.

Ash motions, Bryan seconds' passes unanimously: 7 yes 2 absent

4.2. Discussion and Possible Action: Consider letter to CD1 requesting that they consider the following addresses, currently for lease in Cypress Park, for lease agreements for community support and homeless services:

3232 N Figueroa St (12,026 SF of Industrial Space Available in Los Angeles, CA)

• 1324 Cypress Ave (26,300 SF of Industrial Space Available in Los Angeles, CA)

 Huron Substation 2640 Huron St (4,015 SF Vacant Office Building) https://bit.ly/3aWPDrl

Bryan introduces the idea of sending a letter to CD1 about these locations because GCPNC has expressed a desire to intro new sites to advocate for use for homeless services. Requests that we ask CD1 to do more investigation into these three buildings currently for lease. Romana asks if there is a program for the city to lease buildings; unknown is the response, but they could make a program?

Jennifer recommends that we tie this request to Cedillo's motion in the last item we considered: that since CD1 is interested in extending the shelter program...look into these locations

Romana suggests that we may want to target a specific group, like the elderly or families who are homeless.

Clint suggests that the language of the letter include an ask for specific reasons why they CAN'T use these locations, so we can learn as a board.

Ash motions; Bryan seconds; passes unanimously 7 yes 2 absent

5. New Business and ideas for future meetings Nuevos asuntos e ideas para futuras reuniones Can we get an update on La Morenita property? Rumor that this is going to be a brewery. Jennifer asks how to know when council files are coming up for a vote. Clint/Ash say the process is a little weird - you can subscribe to the updates on a council file, but sometimes you'll only get the update that the council has taken action, not that it has been scheduled.

Jennifer and Chloe met with Kelsey Jessup of the Nature Conservancy and a director from the Bowtie and ask when they can give a report. Ash suggests at the next land use meeting.

Next letter to CD1 about locations we should consider the building on San Fernando that was the former courthouse for mental-related cases that is not currently in use because asbestos, maybe, but there is a large parking lot that could be used for safe parking or a pop-up shelter.
