8. Action Items

8.1 Discussion and Action: Approve the 2024-2025 Fiscal Year Budget and Administrative

Packet for the GCPNC. This includes roles such as second, signer, alternative signer, and card holders. It also includes approval of standing office charges such as interpretation, storage, and minute taker services.

Ash introduces fiscal year admin budget. Asks about being second signer. Dolores nominates herself. Ash asks about an alternate signer. Mayra volunteers. First bank holder is Ash. Second bank card holder; Dolores nominates herself.

Ash put together a sample budget. We have \$32K; probably another 10K rolled over. \$3300 for storage. \$2400 minutes and live interpretation (see budget for further details. Grand total 12K for office. Outreach 3K misc. 6K budgeted for Cypress Rec. 3K for election budget. 8K for NPGs. We can put the rolled over 10K toward NPGs or community improvement projects.

Ash asks for input. Dolores asks about contributing to Neighborhood Congress. Ash suggests pulling funds from Outreach. Mayra asks about election advertising expenses. Ash says this is about allocating large pools of money for the budget, but things can be shuffled around later. Ash talks about election advertising things from years past.

Erica talks about NCs teaming up for events to advertise elections. Canvassing.

Ash says this doesn't lock us into anything. Just sets us up for the upcoming year.

Carmen motions to approve the budget. Dolores seconds. Bryan Yes. Ash Yes, Mayra yes. Teresa yes. Dolores yes. Carmen yes.

Michael: the city provides money, warriors for peace, most of our events are CD1, NC and Warriors for Peace

Michael - last year was Scooby Doo, we'll make a decision soon; Delilah does our IG stuff
