

- 2.2 Elena Chavez, Field Deputy for Councilmember Eunisses Hernandez. Ms. Chavez discussed some of the summer activities such as back to school events, backpack giveaways, binders and notebooks; over 300 items given out in Cypress. - 8.3 Discussion and Possible Action: Request for Action (RFA) to CD1 regarding 1150 N San Fernando Road, a former courthouse facility from the Judicial Council of California, which had been left vacant and was destroyed in a knockdown structure fire on 9/21/24. Ash Kramer motioned to propose a request for action to get an update. Carmen Morales seconded.

8.4 Discussion and Possible Action: Consider submitting a CIS letter in opposition to a proposed development at 3505 Pasadena Ave, formerly Welch's Uniform and Laundry, which raises serious environmental and health concerns. Discuss and vote on the draft letter. Michael Hayden of Lincoln Heights Community Coalition explained that hundreds of trucks a day would be passing through the neighborhood, by schools (around 7), Boys and Girls Club, libraries, a community center as well as churches. Mr. Hayden said this was an environmental justice issue. Mr. Hayden thanked the board for considering a community impact statement; mentioned how this would cause generational harm to our neighborhoods; gave out the website saveave35.com.

- 8.8 Discussion and Possible Action: Consider a Neighborhood Purpose Grant of up to \$5000 to the Friends of Aragon. Representative from the Friends of Aragon discussed that some of the money would be used to help the principal with the cost of busses of around \$5000. They would like to help with \$3000. In addition, funds would be used for yearbooks for the 5th graders, 300 color fliers, banners with their logos, and \$500 dollars for t-shirts.

Dolores Bernal mentioned that the word etc. cannot be used in their proposal; that it could not be left open-ended.

Teresa Roman asked who was covering the costs of the busses now?

Representative said the school covers the costs in partnership with Inner City Arts.

Carmen Morales mentioned roughly around \$1250 for the Zoo tickets, \$750 for lunches and \$500 in transportation. Carmen Morales was looking for the event to take place in December.

Erica Gatica Doughty said the event is possible, it was not a hard no, perhaps if public transportation was used.

Brayn Kramer asked Carmen Morales would inspired her to propose the idea.

Carmen Morales said the community does not always get to go to places like this and that they are not awlays involved in these kinds of activities.

Teresa Roman asked what would happen if there were more than 50 people interested, how would you disnguish or choose between family members, elderly—that was her concern.

Carmen Morales said at this point it would only be open to people over 18 years of age or if children are accompanied by an adult.
