4) Please describe the purpose and intent of the grant.

Our organization is seeking this grant funding to provide essential supplies for local day laborers returning to work in the aftermath of the recent wildfires. With this grant, we aim to distribute supplies such as gloves, air purifiers, masks, boots, and other safety equipment to help safeguard their health. By ensuring workers have the tools they need, we can support their ability to safely resume work while minimizing health risks associated with wildfire cleanup.

5) How will this grant be used to primarily support or serve a public purpose and benefit the public at-large. (Grants cannot be used as rewards or prizes for individuals)

Providing essential supplies and resources to day laborers, who are returning back to jobs post wildfires, is crucial to protecting and supporting these workers that are often excluded in recovery efforts. These workers face hazardous conditions such as poor air quality, toxic ash, and unsafe worksites. By equipping them with protective gear and supplies like gloves, air purifiers, masks, and boots, we help safeguard their health and well-being and the well-being of their families, as they continue the critical work in our homes and neighborhoods.
